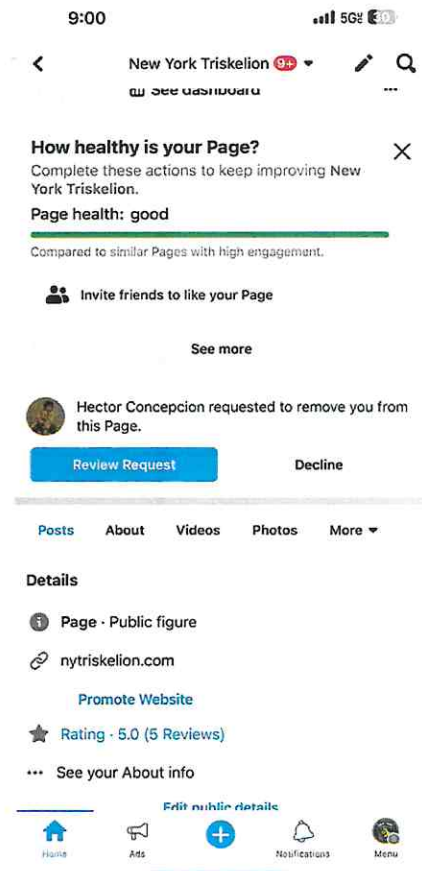
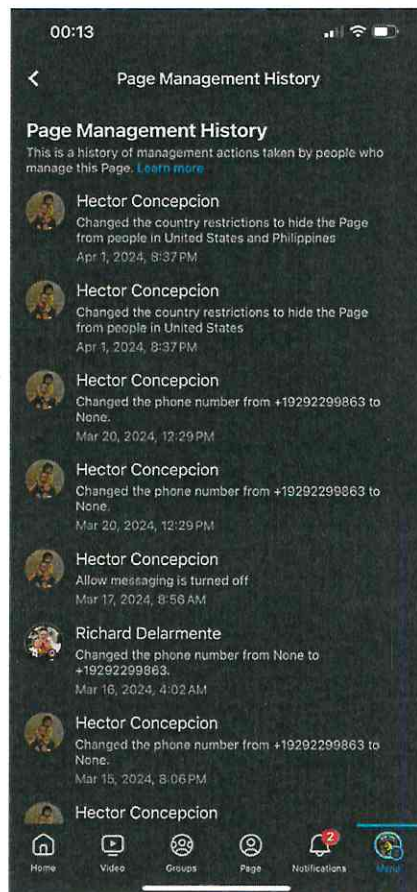
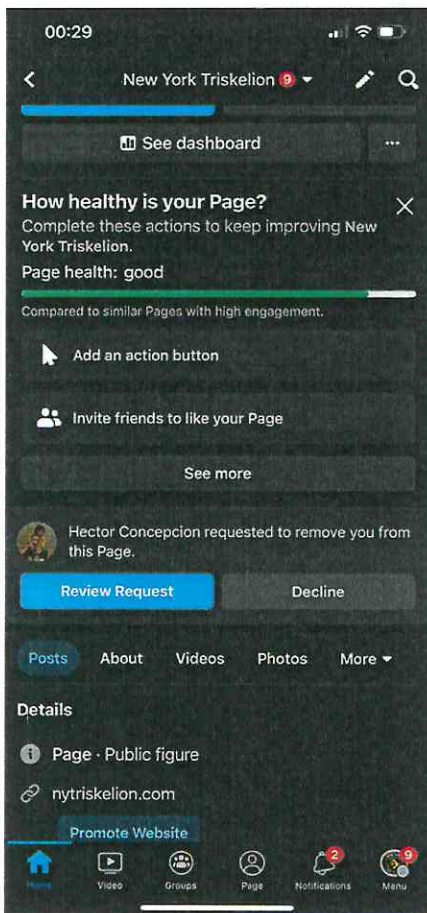
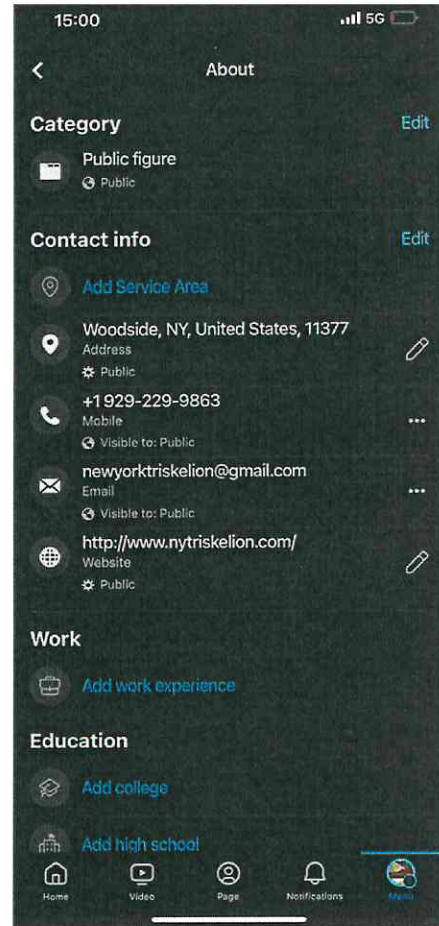
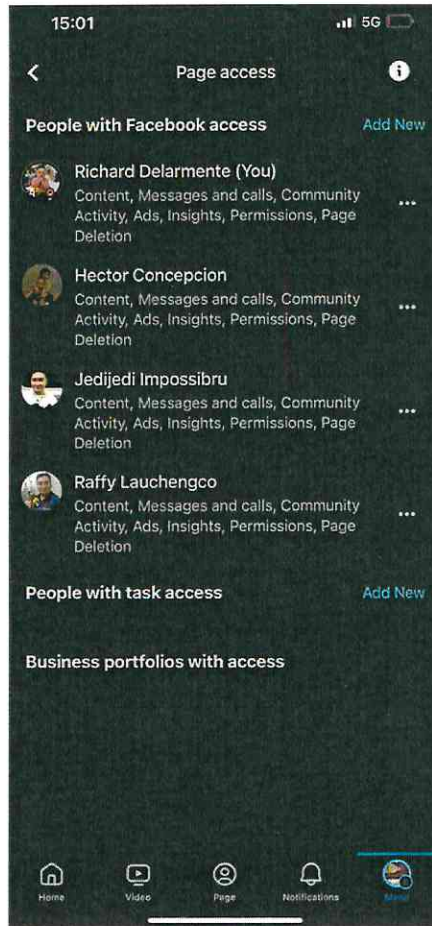
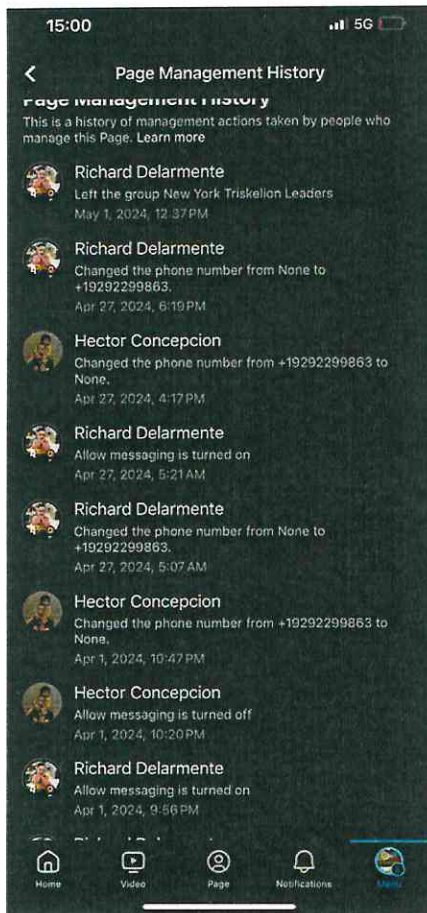
We also respectfully demand that TEST cease and desist from using the name Empire State as we operate in the same geographical area thus effectively causing confusion among Triskelions worldwide.
